Taking a bus or auto, get off at Mithapur from where it is a walking distance of only 1 km. towards Phulelmajra village ) If required, interview can be continued next day.

### Terms & Conditions:

1. The candidate must bring a copy of bio-data giving full particulars along with all original certificates, attested photocopies of all required certificates from matriculation onwards and copy of recent passport size photographs and experience certificate in original (if any) with them which can be submitted at the time of interview.
